# Introduction

The core principles of life, liberty, and the pursuit of happiness are not partisan ideals. They’re the foundation of what makes America great, regardless of political party, regardless of race, regardless of gender, regardless of religion, regardless of national heritage, and regardless of income.

Those principles have always run deep in Nevada, fostering a spirit of being tough, creative, and always believing in a better future for our kids, grandkids, and everyone who comes after us.

But today that spirit is in danger of being snuffed out. We’re at the proverbial fork in the road.

Regardless of party affiliation—or affiliation with no party—we should all agree that elected officials should represent the people of their district with honesty about their views and voting record. But too many politicians of all political stripes tend to tell people what they want to hear for one reason, and one reason only . . .

To get re-elected.

Back in the “old days,” newspapers, TV, and radio served as a somewhat reliable

source of information voters needed to make informed decisions at the ballot box. Those days are long gone.

The rise of cable news channels, talk-radio, online blogs, podcasts, and social media have all but replaced what is often referred to as the “mainstream media.” As a result, newsrooms around the country have been laying off reporters, columnists, and support staff in droves.

“Over time the newspapers have been fading away in relevance,” wrote Elon Musk of X (formerly Twitter). “Not gone—just as writing and mailing paper letters still happens—but no longer the way most people know what’s going on.”

Not coincidentally, trust in mainstream media reporting has fallen, as well.

Axios reported on a Gallup poll in September 2023 which showed that “only 32% of the population reports having ‘a great deal’ or ‘a fair amount’ of confidence that the media reports the news in a full, fair and accurate way.”

Fueling the decline has been the obvious and undeniable evidence that the media has been acting as a propaganda arm of Democrat politicians and far-left extremists rather than objective reporters.

Remember the Black Lives Matter and

Antifa riots in the summer of 2020?

CNN was widely and rightfully ridiculed for an on-air interview in which its correspondent reported on “largely peaceful demonstrations” in Kenosha, Wisconsin—with cars and buildings burning out of control in the background!

Who ya gonna believe, CNN or your own lying eyes?

The media’s bias extends to how it holds—or doesn’t hold—elected officials accountable. Here’s just one example from a May 2021 report by the *New York Times*:

With the White House poised to unveil the largest federal budget in U.S. history, spy agencies investigating whether a lab in China caused the COVID-19 pandemic, and gas prices skyrocketing ahead of a major US travel holiday, President Biden was grilled Thursday . . . about his favorite flavor of ice cream.

“Mr. President, what did you order?” was the first question shouted by a reporter as Biden licked a cone at Honey Hut Ice Cream in Cleveland, Ohio. “Chocolate chocolate-chip,” the commander in chief replied, to oohs and aahs from the fawning press pack.

Indeed, Americans can no longer rely on traditional media to provide “all the news that’s fit to print” in a fair, objective, and impartial manner. *Which is why books such as this little one have become necessary*—to fill in the gaps and give voters accurate information they can use to make informed decisions when they cast their ballots.

Nevada is a “swing” or “purple” state. Voter registration is near even, with Democrats holding a slim majority. Our two U.S. senators are Democrats, but our governor and lieutenant governor are Republicans. So, neither party has a “lock” on statewide elections.

Six years ago, Democrat Jacky Rosen defeated incumbent Republican U.S. Sen. Dean Heller with just 50.41% of the vote and carrying only two of Nevada’s 17 counties—Clark and Washoe. That’s razor-thin in an evenly divided state.

Since then, her time in the Senate has been nothing short of unremarkable, a far cry from the days when Harry Reid—love him or hate him—ruled the roost. He was a larger-than-life political figure in our comparatively small state.

You may not have agreed with him on many of the big issues facing Nevada and our country, but at least you knew where he

stood. The same can’t be said for Sen. Rosen.

Nevadans rarely see her and hardly ever hear from her—except during election season. It’s as if she borrowed Harry Potter’s “Invisibility Cloak.” And when she does speak out, it’s often in D.C. wonk talk, from both sides of her mouth, trying to have her cake and eat it, too.

The public image she puts forward is that of a moderate who works with both sides of the aisle in a bipartisan fashion. *But her actual voting record tells a totally different story.*

*Sen. Rosen voted with Biden 98.6% of the time* on Senate votes that Biden had “made his stance known about” according to an analysis by FiveThirtyEight. A separate analysis by ProPublica showed she voted with Democrat Majority Leader Chuck Schumer 95% of the time on bills “deemed major.”

That’s hardly “moderate,” and certainly not bipartisan.

There are a pair of old sayings our moms taught us: “You’re known by the company you keep” and “Birds of a feather flock together.”

Sen. Rosen and Biden/Harris are joined at the hip. Heck, she even flew on Air Force One last December with the president on his way to announce taxpayer funding for the high-speed “Train to Nowhere” boondoggle from Las Vegas to Victorville, California.

On January 20, 2021—the day Biden and Harris were sworn into office—Sen. Rosen issued the following press statement:

On day one, President Biden is already hard at work to enact an agenda that will help to improve the lives of Nevadans and help restore the soul of our nation. . . . I look forward to working with this Administration in the years to come.

Problem is, much of the Biden/Harris/Rosen “day one agenda” is responsible for the rising prices that are sucking money out of your wallets and bank accounts, including:

- Extending the eviction freeze on deadbeat renters, which resulted in rent increases on everyone else to make up for the difference
- Rejoining the “Paris Climate Accords” to push expensive, unreliable “green” energy, and
- Cancelling the Keystone XL pipeline, which then contributed to sky-high gas prices at the pump.

In addition, Biden/Harris/Rosen froze collection on deadbeat college grads who

think you—the taxpayer—should be paying for the student loans they voluntarily took out themselves.

Also on day one, Biden/Harris/Rosen enacted a number of agenda items that ultimately resulted in the ongoing border crisis, including

- Adding illegal immigrants in the U.S. Census count of citizens
- Abolishing the ban on refugees from terrorist countries
- Cancelling former President Trump’s executive order to detain and deport illegal immigrants who get past the border and move to the U.S. interior—thus making *every* state a “border state”
- Halting construction of the U.S.-Mexico border wall, which has resulted in a flood of illegal immigrants pouring across the border with no health screening or criminal background checks.

At least on this one, Sen. Rosen has been consistent. In 2018, while she was still in the House of Representatives, she voted against the “Securing America’s Future Act,” which would have spent \$25 billion for border security.



“It built a wall,” she said in a statement. “It hurt immigrants.”

No, it deterred *illegal* immigrants.

During her 2018 campaign, Sen. Rosen again said, “The idea of a physical wall” was “the wrong idea.”

“If you build a six-foot wall,” she explained, “somebody may jump eight feet.”

And she continued to pooh-pooh construction of a border wall/fence in a January 2019 interview with the *Las Vegas Sun*, declaring, “What we have to quit talking about is a border wall.”

Then why is there a wall/fence surrounding the White House? Why did President Biden build a wall around his Delaware beach house? Why does Congress erect a wall/fence around the Capitol for events? Does Sen. Rosen have a wall protecting her own home? Inquiring minds wanna know.

When asked if she was worried that President Biden’s dropping popularity might drag her own campaign down, Sen. Rosen replied that she would “happily” campaign by his side and that what the two of them together have done in Nevada “has been a big success story.”

Most average Nevada voters looking at their gas bill, their grocery bill, and their rent would disagree.

Indeed, on the twin pillars that make up “Bidenomics”—the “American Rescue Plan” and the horribly misnamed “Inflation Reduction Act”—Sen. Rosen voted in lock-step with President Biden, Vice President Harris, and her Democrat colleagues.

In March 2021, she said she was “proud” to vote for President Biden’s stimulus plan—which stimulated nothing but sky-high inflation—and wrote, “I applaud President Biden for signing this bill into law.”

The bottom line is Sen. Rosen’s allegiance has been to President Biden, Vice President Harris, and those who are far, *far* from America’s moderate center on many of the key critical issues we face—especially illegal immigration and the economy.

This book will shed light on those issues and the truth about where Sen. Rosen actually stands on them—positions her consultants and handlers would rather you not know about and the press tries to hide. It will give you important information you can use to make an informed decision in November’s general election.

## Chapter 1

### The Rise of Rosen

U.S. Sen. Jacky Rosen reminds me of Punxsutawney Phil, the famous Pennsylvania groundhog that emerges from his hole once a year. He makes a big media splash for a couple hours, then retreats back into his hole, not to be seen or heard from again for another 364 days.

Sen. Rosen does the same thing between elections, and her rise to power in the Senate can be attributed to an old axiom in politics: it's not what you know; it's who you know.

The first-term senator has never been mistaken for a deep thinker or policy expert. Her true talent lies in cozying up to the movers-and-shakers in the world of politics and obediently going along to get along with Democrat leaders.

She was recruited to run for Congress in 2016 by then Senate Minority Leader Harry Reid and was elected in large part due to support from his political "Reid Machine."

In her run for U.S. Senate in 2018, the *Nevada Independent* described her this way:

Rosen is the product of a well-oiled Nevada political machine that ran through a laundry list of candidates to run for Nevada's 3rd Congressional District in 2016 before her name was even added to it—a machine that thought a genial, inoffensive first-term congresswoman would be compelling and, perhaps more importantly, hard to attack.

In other words, no one knew where she really stood—electoral gold for a party now increasingly associated with its more extreme wing. Still, how did this virtual unknown get so far so fast politically?

She dipped her toes into politics as a campaign volunteer for President Barack Obama and Sen. Harry Reid before being tapped in 2016 to run for Nevada's 3rd Congressional District seat. She narrowly defeated her GOP opponent by just 3,943 votes out of more than 300,000 votes cast.

It was the third-closest congressional race in the country.

While still serving in her first term in the House of Representatives, Rosen was picked by her party bosses in 2018 to run against then incumbent Sen. Dean Heller. She won

handily by five percentage points, again with the help of the “Reid Machine.”

But things have changed dramatically since then.

Sen. Reid—architect and primary funding source for the political machine he built—passed away in late 2021. As such, the Reid Machine ain’t what it used to be.

In fact, in 2022, Nevada was the only state in the country where a Republican defeated an incumbent Democrat governor. And Sen. Rosen’s Democrat colleague, Sen. Catherine Cortez Masto, only barely won re-election by 7,928 votes out of more than a million cast.

Voter registration has changed significantly, as well.

Going into the 2018 general election when Rosen was last on the ballot, Democrats outnumbered Republicans in Nevada by 74,923 voters. Going into the 2024 election cycle, that lead had shrunk to 41,192 *and that gap keeps closing*.

Both of those developments help explain why Nevada’s U.S. Senate seat in 2024 is ranked as one of the Top Five vulnerable seats for Democrats. Which is not to say flipping the seat is a slam dunk for Republicans. Money is still the mother’s milk of politics—and Rosen has a U-Haul trailer full of it.

In the fourth quarter of 2023, heading into this election season, she reported raising a staggering—by Nevada standards—\$3.2 million and had \$10.6 million cash on hand, “a record,” the *Nevada Independent* reported, “for an incumbent senator in Nevada at this point in the election cycle.”

Indeed, Sen. Rosen has become a master at the “insiders” game in Washington, D.C.—with or without Sen. Reid. She knows that while money can’t buy you love, it often *can* buy you an election.

So where is Rosen’s money coming from this election cycle? Keep reading.

## Chapter 2

### Show Me the Money!

In the blockbuster Hollywood movie *Jerry Maguire*, Cuba Gooding Jr. played a brash but talented football player. Tom Cruise played his sports agent, Jerry Maguire.

In the movie's hilarious and most memorable scene, Gooding, shirtless and dressed in burgundy sweatpants in his kitchen, has Cruise, sitting at his desk dressed in a white shirt and tie, on the phone.

Desperate to keep Gooding's business, Cruise asks, "What can I do for you?"

Gooding—dancing and bouncing up and down to rap music in the background—replies, "It's a very personal, very important thing. Hell, it's a family motto. Are you ready, Jerry? Here it is. *Show me the money!*"

Gooding then presses Cruise to repeat the phrase—louder and louder. Cruise ultimately yells into the phone, over and over again, "SHOW ME THE MONEY!!!"

To which Gooding calmly replies, "Congratulations, you're still my agent," and hangs up.

That's pretty much D.C. politics in a nutshell.

As award-winning columnist P.J. O'Rourke once noted, "When buying and selling are controlled by legislation, the first things to be bought and sold are legislators."

Sad, but true. If a special interest wants an audience with, or favor from, an elected official, the politician's motto is, "Show me the money!"

Now, the average voter can howl at the moon and curse the darkness over this, but the best we can do is to "follow the money" *and see who's trying to buy and sell our legislators.*

In Jacky Rosen's case, it's quite ugly. But it's not just the amount of money she's raised. It's who and where that money has come from. Fortunately, the Federal Election Commission requires political donations to federal candidates to be reported. So, we have Rosen's money numbers through March of 2024.

While you're trying to figure out how pay for a tank of gas and a pair of Happy Meals at Mickey D's, Sen. Rosen's been wolfing down shrimp cocktails at swanky Hollywood fundraisers with Jane Fonda, Steven Spielberg, and other left-wing celebrities.

Indeed, according to a 2023 report at OpenSecrets.com, Rosen had raised about \$325,000 from individuals in the “TV/Movies/Music” industry alone, leading Michael McAdams to quip, “With how frequently Jacky Rosen is in Hollywood, you’d think she’s pitching a movie script, not running for U.S. Senate.”

Worse, the single largest pool of money going into Rosen’s campaign bank account has come from lobbyists and special interests in our nation’s capital and three other states! When looking at these staggering numbers, who do you think Sen. Rosen is representing when she casts votes on the Senate floor?

Here are the totals for just these three states/D.C. through March 2024. More dollars have arrived since then.

- Washington, D.C.: \$5,543,647
- Massachusetts: \$4,699,200
- California: \$2,597,384
- New York: \$1,818,841

The total amount from people and special interests across all other states, excluding Nevada, is almost \$20 million. Half of this total comes from corporate and other political action committees. What are these

individuals and PACs expecting Senator Rosen to do for them rather than for you? Now, compare that to what Sen. Rosen had raised in our state of Nevada: just \$1,072,713.

In other words, 95% of Rosen’s money came from people and groups NOT in Nevada! *That’s twenty times as much* as our people here donated to her. Whose side will she be voting for next year if re-elected? *Theirs or yours?*

Show me the money, indeed!

## Chapter 3

# Biden/Harris Border Crisis: An Open Door with Deadly Consequences

A couple years ago, I went on a cruise to Mexico.

While docked in Puerto Vallarta, we decided to take a bus tour around the city. As the bus passed the local Home Depot, our Mexican tour guide deadpanned, “And over on your right is where the Americans hang out looking for work.”

Everyone erupted in laughter!

No one was offended. Nobody got their feelings hurt. Nobody demanded the tour guide be sent to “sensitivity training.” It was just good-natured humor—something seriously lacking these days in U.S. politics, especially when it comes to the issue of immigration.

*Illegal* immigration. There’s a difference. A big difference.

The issue has become so divisive because some Democrats want to let everybody in

while some Republicans want to kick everybody out. What’s called for is balance.

There are legal ways to enter our country. And insisting that those wishing to move here follow the rules and do so legally is not “racist” or anti-immigrant.

A study by the Brookings Institution in March 2024 revealed that “the Biden administration is now annually allowing into the country *almost three times as many illegal immigrants as legal ones.*”

It’s plain, old-fashioned common sense not to open your door and let a complete stranger into your home without knowing who they are, what they’re capable of, or what their intentions are. Yet that’s exactly what Biden/Harris and their allies in Congress have been doing on our southern border for almost four years now.

With deadly consequences.

The list of violent crimes against American citizens by those in our country illegally continues to grow. But none captured the public’s attention like what happened to Laken Riley on February 22, 2024.

Laken was a bright, young nursing student at Augusta University in Athens, Georgia. While out on a morning jog on campus, she was kidnapped and killed. Her

body was found in a wooded area near the jogging path.

A 26-year-old Venezuelan who was in the country illegally was arrested and charged with Laken's murder.

In his State of the Union address on March 7, 2024, President Biden was pressured to address Laken's murder and "say her name." But he mispronounced it before noting, accurately, she had been "killed by an illegal."

After the speech, many on the left criticized Biden for referring to Laken's killer as an "illegal" rather than "undocumented." Of course, he was "undocumented" because was in our country illegally!

To be fair, most immigrants—legal and illegal—are truly coming here to make better lives for themselves and their families. But it's also true that a frightening number are moving here with evil in their hearts and hellbent on causing death and destruction.

As *Las Vegas Review-Journal* columnist Debra Saunders noted in March 2024,

There were 6.3 million migrant border encounters in the three years that followed [the Biden/Harris] inauguration. . . . Behind those statistics is a trail of misery, thirst, rape, robbery and abandonment. A truly compassionate

executive would have discouraged the boom in human trafficking from the start, because an open border with insufficient vetting enables predators to sneak in as they move among the sheep.

And as the old saying goes, one bad apple can spoil the whole barrel.

Indeed, not a day seemingly goes by that doesn't include a media report of someone in the U.S. illegally who has raped, robbed, killed, or maimed an American citizen. Yes, we have home-grown criminals who do those things, too. But why import more?

Worse, imagine the death and destruction that could be inflicted on innocent Americans by just one terrorist slipping into the country!

In fact, it was reported in June that eight illegals on the terrorist watch list were caught in our country after having been previously "processed" and then "let go" at the border. How many more are there?

Make no mistake, Latinos themselves are starting to voice opposition—especially in neighboring California where legislators have extended driver's licenses, in-state tuition, voting rights, and health care to illegal immigrants while declaring themselves a "sanctuary state."

Gustavo Arellano is a columnist for the *Los Angeles Times* who is “the child of two Mexican immigrants, one of whom came to this country in the trunk of a Chevy.”

Last February he inked a column pointing to polls showing that “in California, Latino support for undocumented immigrants and measures to help them has steadily eroded over the last two decades.”

He cited a Public Policy Institute of California survey showing *that three out of four Latinos* considered illegal border crossings to be either a “crisis” or a “serious problem.”

“Latinos in California,” Mr. Arellano observed, “are becoming almost as skeptical of unchecked illegal immigration as their white neighbors. Advocates continue to demonize white people who oppose illegal immigration as uncaring racists,” he concluded. “But one day—sooner, rather than later—Latinos will be indistinguishable from them on this question.”

Thanks to the policies of Biden/Harris Democrats, *every* state—including Nevada—is now a border state suffering the consequences of illegal immigration. And Sen. Rosen seems to have had an “election year conversion” on this issue.

In February 2019, Sen. Rosen declared there was “no justification” to declare a national emergency at the border. But in February 2024, she tweeted, “The situation at our southern border is a crisis.”

What changed? The Biden/Harris/Rosen agenda was put in place. With deadly consequences. Literally.

And, of course, Rosen has to face the voters this year.

Yes, we are a nation of immigrants. But more importantly, we’re a nation of laws. And if you can’t come into our country legally, then you shouldn’t be coming in at all.



## *Chapter 4*

### **Biden/Harris Crime Wave: Knock, Knock . . . Who's There?**

Remember the “old days” when you could go to bed and leave your doors unlocked without worrying about being killed in your sleep? Not anymore.

On Wednesday evening, July 21, 2021, Amanda Nowak was home alone in Las Vegas when a big tattooed man with a scraggly beard and ragged tank top shirt rang her doorbell and called out, “I just have a couple of questions for you.”

Amanda didn't respond. She hid while calling 911. The incident was captured by a Ring camera video system that had been installed on the porch. The video went “viral” all across the country.

As the man began walking away, Amanda's husband—who was monitoring the terrifying encounter remotely away from the house—asked who he was and what he wanted.

“What I'm looking for is the girl in the house 'cause I'm going to rape her and kill

her,” the crazed man replied, adding that he had a gun and a knife. “Can you have her open the door?”

Moments later he left, before police officers arrived. He was identified from the Ring video footage and arrested a couple days later.

But it's not just our homes that have become deadly danger zones.

On March 12, 2022, 18-year-old Naomi Irion disappeared from a Walmart parking lot in Fernley, Nevada, while waiting for a bus to take her to work.

Her body was found in a ditch two weeks later. She'd been kidnapped, raped, and shot to death. Her killer had a long criminal record—including accessory to murder—that dated back to when he was a juvenile.

On October 6, 2022, a pair of young showgirls working on the Las Vegas Strip as goodwill ambassadors for tourists were attacked in broad daylight on the sidewalk, without provocation, by a complete stranger from Los Angeles.

He then pulled out a knife and stabbed both girls, one fatally through the heart. She bled out on the sidewalk in her friend's arms. Three other girls were wounded in the attack and another man was killed.

On August 14, 2023, Andreas Probst—a retired police chief—was out for an early morning bike ride in northwest Las Vegas. A pair of teens ran him over and killed him. They filmed the entire episode, which was posted on social media.

One was recorded yelling, “Yeah, yeah, yeah . . . hit his ass!” before slamming into the back of him. Upon his arrest, one of the accused was recorded on a bodycam video laughing and taunting police.

On December 27, 2023, Jerry Lopez of Las Vegas—a 39-year-old husband and father to seven; six of whom were adopted, five with special needs—was at the wrong place at the wrong time.

While on his way to work, he was carjacked at gunpoint and ultimately killed by the car-jacker after a high-speed chase with police. The man was wanted for killing his own mother earlier in the morning.

On January 3, 2024, Deobra Delone Redden—a man with a long criminal record of mostly violent offenses—“leaped over a defense table and the judge’s bench, landing atop (the judge) and sparking a bloody brawl with court officials and attorneys.”

A closed-circuit recording of the incident showed Judge Mary Kay Holthus “falling back from her seat against a wall” as Redden

“grabbed her hair, toppling an American flag onto them.”

No one is safe these days. Not in your home. Not in your car. Not walking down the sidewalk. Not even in a court of law. Your head needs to be on a swivel at all times.

Soft-on-crime politicians, “social justice warriors,” and Biden/Harris Democrats such as Sen. Rosen are more concerned with the welfare of criminals than victims. We have revolving doors on our prisons, while some judges and district attorneys hand out “Get Out of Jail Free” cards.

And then there’s the whole “defund the police” movement.

You’d think Biden/Harris Democrats in Washington, D.C., would appreciate the danger we ordinary citizens face when there’s a shortage of police officers—especially after Rep. Angie Craig was assaulted in the elevator of her D.C. apartment and Rep. Henry Cuellar was carjacked at gunpoint.

Such attacks are not surprising considering D.C. aggressively pursued a “defund the police” policy starting in June 2020. There simply aren’t enough cops on the street to round up the bad guys—and the bad guys know it.

This has allowed hardened, violent, career criminals to continue terrorizing our

neighborhoods and preying on law-abiding citizens. But even if you're not directly the victim of a crime, you're still paying the price.

The ongoing "Biden/Harris Crime Wave" includes your old-fashioned, garden-variety shoplifting, as well as "smash-and-grab" gangs looting retail stores. The result has been empty shelves and ordinary products being locked behind glass cases.

In September 2023, CNN reported that Target was closing nine stores in major cities "because theft and organized retail crime are threatening the safety of our team and guests and contributing to unsustainable business performance."

The following month, the *Washington Post* noted that Walmart, Home Depot, Lowe's, Dollar Tree, Dick's Sporting Goods, and Ulta all raised concerns about thefts, noting that retailers "routinely stock deodorant and name-brand shampoo in plexiglass cages."

It's time to make crime illegal again. But over the past five-plus years, what has Sen. Rosen done to fix the situation? She's tried to make it worse.

In 2020, Sen. Rosen co-sponsored the "George Floyd Justice in Policing Act." The bill declared that if there's evidence that

police actions like interviews, traffic stops, and searches affect people of different races differently, that alone was proof of racial profiling.

"This is absurd," editorialized *National Review*. "There are bound to be disparities in such police interactions because there are disparities in crime rates. . . . Worse, the bill makes officers liable for these disparities—over which they have no control."

*National Review* went on to illustrate the absurdity of Sen. Rosen's legislation by noting its natural extension if you expand beyond race:

Ninety-two percent of the U.S. prison population is male. That's because men commit the vast majority of crimes in this country. To avoid potential legal action, law-enforcement officers and agencies will need to either manufacture reasons to stop, frisk, and perform more searches on more women, or stop men far less often. Both approaches would be insane.

All Sen. Rosen's bill would do, the editorial concluded, is "render our law enforcement less effective, our communities less safe, and our system less just."

In fact, as recently as January 2024, KTNV Las Vegas reported that police shortages continue across the Las Vegas valley. It's no wonder, since so many cops are leaving the force or choosing not to sign up in the first place.

With "friends" like Sen. Rosen and other Biden/Harris Democrats, they don't need any more enemies.

## *Chapter 5*

### **The Price Is Wrong**

The television game show *The Price is Right* made its debut on September 4, 1972, with the legendary Bob Barker as its host. It's the longest-running network game show in the United States.

Four contestants are chosen from the studio audience and are invited to "come on down" to test their pricing knowledge of various consumer products. After an item is rolled out and displayed, contestants are asked to guess the retail price without going over. Winners are awarded big prizes, such as luxury vacations, appliances, and even cars. Unsuccessful contestants get consolation prizes ("Turtle Wax!").

Sadly, many Americans these days play a version of the show every time they walk into a grocery store, gas station, drug store, the mall, or even "discount" department stores.

As they load up their shopping carts, they pray the total for their purchase doesn't go over the total they have in their wallet. Often, they're embarrassingly forced to "put

something back” at the checkout counter because they don’t have enough money to afford everything they need.

Cost of living increases since 2021 are killing family budgets.

The cost to buy a house is up. The cost to rent an apartment is up. The cost to take a plane, train, or automobile is up. The cost of taking a vacation is up. The cost to hire workers is up. The cost to put food on your table is up.

A News3 Las Vegas report in April 2024 provided the gory details:

Americans are shocked by how expensive their groceries and restaurant bills are. McDonald’s prices have doubled, and Olive Garden is now too expensive for many. . . . Back in 2014, you could get a McDouble for just \$1.19, and today you will pay \$3.19. A 10-piece McNuggets meal was just \$5.99, and today you’re going to have to pay \$10.99. If the shake machine is working, you will pay \$4.49 for an Oreo McFlurry; a decade ago, it was just \$2.39.

It seems the only thing down is the balance in your checkbook.

While inflation is always a problem of

modern-day life, it’s gotten far worse since President Biden and Vice President Harris were elected. And Nevadans are paying the price even worse than many other states.

In 2020, the average cost of gas in Nevada, according to GasBuddy, was \$2.20/gallon. By June 2022, the cost had more than doubled, shooting up to \$5.03/per gallon.

Putting this in real numbers, the cost to fill up your average 16-gallon tank before Biden and Harris took office was around \$34. Three years later, filling that same tank cost you \$54. That extra \$20 for 50 fill-ups a year adds up to \$1,000. And those higher fuel costs have meant higher prices for everything else, as well.

In fact, last February the *Las Vegas Review-Journal* reported that “the cost to buy natural gas increased by over 75 percent.” It added that “the average January gas bill for a Southern Nevada resident was \$205, a 50 percent increase over last January’s average of \$136.”

How many Happy Meals could that \$69 difference buy? Certainly not as many as before. In fact, it costs almost as much to buy lunch today as it used to cost to buy dinner.

In March 2024, a receipt posted by a customer of the Five Guys hamburger chain went viral on social media. The cost for a

bacon-cheeseburger, small fries, and regular drink totaled a whopping \$24.10!

And while the age-old question of which came first, the chicken or the egg, remains unresolved, the rising cost of chicken was nothing compared to the rising cost of eggs. The *New York Times* noted that in February 2021, the cost for a dozen eggs was \$1.59. By 2023, it had shot up to \$4.21.

The shortage of eggs was so bad in some places that stores limited purchases to no more than two dozen at a time. And the cost was so high that a Las Vegas gentleman's club humorously advertised: "Lap Dances . . . Cheaper Than Eggs."

In January 2024, the *Las Vegas Review-Journal* reported that "residents in Nevada are paying more for their groceries than almost any other state in the nation." Not surprisingly, only Californians were being hit harder.

Meanwhile, the price you and I are paying for government is also shooting up through the roof. The national debt in the spring of 2024 was over \$34 trillion. And to give you an idea of just how staggering a "trillion" is, consider this: \$1 trillion divided by the number of U.S. households who pay income taxes is \$20,000. Every \$1 billion of spending by the government costs these

same households about \$20. May not sound like much at first. But when you realize that U.S. spending in far-away Ukraine is \$174 billion, that's almost \$3,500 per taxpaying household!

And our national debt is rising by \$1 trillion dollars every 100 days!

As the *Las Vegas Review-Journal* noted in a March 28, 2024, editorial on how much of that money is being wasted,

*Reason* magazine's Eric Boehm highlighted a handful of the most egregious examples of unnecessary federal spending, including \$2.5 million for a kayaking facility in New Hampshire, \$2.7 million for a bike path in a small West Virginia town and \$3.5 million for the outfit that runs Detroit's annual Thanksgiving parade.

A group backed by former Vice President Mike Pence also compiled a list of what it views as wasteful "woke" pork initiatives, including \$1.1 million for "climate resilience and equity" in Massachusetts, \$200 million for "gender equity and equality action" and \$400,000 to a New Jersey company that provides "gender-affirming clothing."

*And Sen. Rosen voted for all of it.*

She's voted for every piece of Biden's foreign policy and economic agenda (Bidenomics), claiming it would "bring much-needed relief to Nevadans." Which, of course, it hasn't. Just look at your grocery bill.

In fact, Larry Summers, President Obama's former economic adviser, blasted the Bidenomics plan as the "least responsible economic policy we've had in the last 40 years," while *The Economist* reported that "the main effect of the president's economic policies has been to boost prices."

And then there was Biden and Harris's horribly misnamed "Inflation Reduction Act"—which liberal media outlets such as the *Washington Post* and Vox admitted had driven inflation up, not down, after its passage.

Even Sen. Rosen herself sort of admitted the failure of Bidenomics. In January she tweeted: "Families shouldn't have to break the bank to put food on the table, but the price of groceries is out of control."

She's been in D.C. almost eight years. And she's *almost always* supported Biden/Harris and voted for the Democrats' policies that are sucking money out of your wallet like a turbo-charged vacuum cleaner.

When it comes to product and service after product and service, the price isn't right. It's wrong. And Biden/Harris Democrats such as Sen. Rosen are responsible for all of it.



## Chapter 6

### Boys Will Be Boys, Unless . . .

In the 1990 movie *Kindergarten Cop*, Arnold Schwarzenegger played an undercover police officer who found himself teaching a kindergarten class. In one memorable scene, a young boy deadpans, “Boys have a penis, and girls have a vagina.”

At the time, who would have ever thought such a simple, accurate statement would become controversial?

At the confirmation hearing for President Biden’s Supreme Court nominee Ketanji Brown Jackson, Sen. Marsha Blackburn asked Jackson to define the word “woman.” That resulted in the following exchange:

“I can’t.” Jackson replied.

“You can’t?” Blackburn asked.

“Not in this context. I’m not a biologist,” Jackson said.

I’m old enough to remember when you didn’t have to be a biologist to know what a woman was. But that’s where we are today.

In the early 1970s, comedian Flip Wilson

had audiences rolling in the aisles when he dressed as a woman and performed as the sassy Geraldine Jones. Wilson didn’t claim to be a woman. He was just dressing up like one.

In the 1980s, Jamie Farr became a television star on the hit show *M\*A\*S\*H* as Corporal Max Klinger—a man dressing as a woman in the hope of getting tossed out of the Army and sent home during the Korean War. Klinger didn’t claim to be a woman. He was just dressing up like one.

Over many years, a number of other high-profile actors have shimmied into a dress and slipped on a pair of heels for laughs, including Dustin Hoffman in *Tootsie*, Robin Williams in *Mrs. Doubtfire*, and Tom Hanks in *Bosom Buddies*.

But those fun-filled days are over. No longer is it acceptable to find men pretending to be women funny. Comedians are being “cancelled” for daring to tell jokes about the transgender community.

But it’s not just the world of comedy that’s being attacked by the radical trans movement. J.K. Rowling—author of the best-selling Harry Potter series—landed in hot water in June 2020 when she took issue with the phrase “people who menstruate” in a tweet.

“I’m sure there used to be a word for those people,” she wrote. “Someone help me out. Wumben? Wimpund? Woomud?”

The backlash was fast and furious. She was denounced, pilloried, scorned, ridiculed, and all but burned at the stake. She’s lucky she wasn’t sent to Azkaban prison with the Dementors. (You’ll have to read the books.)

But unlike many of her celebrity colleagues, Rowling remained unbowed and defiant, defending her position—supported, of course, by science—that there are only two genders: male and female.

The radical trans community feels otherwise. If a man decides he wants to “identify” as a woman, then you better call him “she/her” or suffer the wrath of the Pronoun Police. In fact, people have been fired from their jobs for “misgendering” a transgender.

And then there’s the whole issue of men competing in women’s sports.

In a profile article published in 2018, the *Nevada Independent* reported that Sen. Rosen noted that “when she was young there weren’t even sports teams for girls at her school.”

Well, it’s back to the future. Yes, there are now sports teams for girls in high schools and colleges. However, some of those teams now include biological boys and men.

Riley Gaines was a 12-time All-American swimmer who was forced to compete against a biological male, William “Lia” Thomas, in the 2022 NCAA Women’s Swimming & Diving Championships.

Gaines “lost,” but decided not to accept the unfairness of men competing against women in women’s sports and has become a national spokesperson—including testifying before Congress—on the issue.

“Most people sat idly by and allowed this injustice to happen,” Gaines explains on her website. “So, I had to speak out. Because the truth matters. And the truth is there are only two sexes. Men are men. Women are women. There’s no doubt we were created equal—but we’re not the same.”

And for daring to speak out, Riley has been subjected to threats, abuse, and ridicule.

“Been angry for years now,” tennis great Martina Navratilova wrote about the controversy. “The unfairness is off the charts. I will say it again—keep women’s sports female. It is not the place for failed male athletes.”

Nor are women’s restrooms, locker rooms, or dressing rooms. *But Sen. Rosen doesn’t agree.*

In 2019, Rosen co-sponsored a bill to expand Title IX to include transgender

students. Title IX prohibits sex-based discrimination in any school that receives funding from the federal government, thus ensuring equal opportunities for girls, especially in sports. Rosen’s bill guts that entirely.

In 2021, she cosponsored the “Equality Act” which, among other things, specifically stated that “an individual shall not be denied access to a shared facility—including a restroom, a locker room, and a dressing room—that is in accordance with the individual’s gender identity.”

And in March 2024, Rosen voted against an amendment proposed by Republican Sen. Tommy Tuberville that would have prevented men from competing in women’s sports.

His amendment would have withheld federal funding from any college or university “that permits any student whose biological sex (recognized based solely on a person’s reproductive biology at birth) is male to participate in an athletic program or activity designated for girls or women.”

All 51 Biden/Harris Democrats—including Sen. Rosen—voted against the Tuberville amendment.

But that’s not the worst of it. It’s one thing for adults to fight over stuff like this,

but when you drag kids into it, that’s a completely different story.

Former Wisconsin Gov. Scott Walker pointed to a Young America’s Foundation report on the Ames, Iowa, school district:

As part of their curriculum, preschool and kindergarten students were given coloring pages with transgender characters. They were encouraged to decide if they wanted to be a boy or a girl or something else. This is how young they are starting the indoctrination.

Walker went on to note that certain school districts are not only promoting the transgender agenda in elementary school classrooms but are training teachers not to tell parents.

He pointed out a slide from one such training workshop in which teachers were told, “*Remember, parents are not entitled to know their children’s identities.*” That knowledge must be earned.”

Outrageous!

No matter where you stand on the transgender issue, we all should be able to agree that parents should not be shut out of what their kids are being taught and that teaching sex-related classes to kids who are still

trying to master finger-painting is totally inappropriate.

Too bad Biden/Harris Democrats such as Sen. Rosen don't agree.

## *Chapter 7*

# **The American Race Card: Don't Leave Home Without It**

A few years ago I read a humorous definition of "racist." It defined a racist as "anyone winning an argument with a liberal." And yes, under that definition you don't have to be white to be a "racist."

In fact, in a column published by the *Los Angeles Times* during the September 2021 special election for governor in California, Erika Smith wrote that black candidate Larry Elder was "the black face of white supremacy."

If everybody's a racist, then nobody's a racist.

"If you have always believed that everyone should play by the same rules and be judged by the same standards," wrote Thomas Sowell, a great American economist who happens to be black, "that would have gotten you labeled a radical 60 years ago, a liberal 30 years ago, and a racist today."

Which brings us to the whole DEI

movement in which white Americans are routinely demonized in news stories, television shows, advertising, and even in our schools.

DEI stands for “Diversity, Equity, and Inclusion,” though critics say it really should stand for “Didn’t Earn It.” Such programs are simply reverse discrimination. Certain minority groups (often black or Hispanic) are given preference over other groups (often white or Asian) for no reason *other than* their skin color.

It’s wrong—just plain wrong—no matter who is involved. Focusing on “diversity, equity, and inclusion” overshadows the importance of rewarding skills and achievements.

There was, however, some good news on this front in 2023. The U.S. Supreme Court struck down race-based affirmative action in college and university admissions, thus moving the nation back towards a truly color-blind society.

Let’s face it, there are still real racists—black, white, and everything in between—among us. But to accuse someone of racism simply for having a different opinion is ridiculous.

But that hasn’t stopped many from “playing the race card” at every opportunity.

In fact, columnist Adam Mahoney actually found a way to race-hustle last April’s solar eclipse, writing: “While the event will cast a brief shadow on life in Texas, it sheds a light on scientific fields that have been mainly out of reach for Black folks.”

Or take actor Jussie Smollett. In case you missed or forgot it, here’s how Wikipedia describes the “hate crime hoax” Smollett perpetrated on Americans:

On January 29, 2019, American actor Jussie Smollett approached the Chicago Police Department and reported a hate crime that he had staged earlier that morning. He planned the hate crime with two Nigerian brothers, Abimbola and Olabinjo Osundairo, who had worked as extras on the set of television drama *Empire*, in which Smollett was a cast member.

During the staged attack, which took place on East Lower North Water Street in Chicago’s Streeterville neighborhood, the disguised brothers shouted racial and homophobic slurs while one poured bleach on Smollett and the other placed a noose around his neck.

In addition to falsely reporting that

he had been attacked by two unknown individuals, Smollett described one of them as a white male. He also told police the men shouted, “This is MAGA country” during the attack, a reference to the Trump political slogan “Make America Great Again.”

The brothers later testified that Smollett staged the attack near a surveillance camera so that video of it could be publicized.

Democrats—including President Joe Biden and Vice President Kamala Harris (both endorsed by Sen. Rosen)—immediately rushed to Smollett’s defense.

“What happened today to @JussieSmollett must never be tolerated in this country,” Biden tweeted. “We must stand up and demand that we no longer give this hate safe harbor. . . . We are with you, Jussie.”

“@JussieSmollett is one of the kindest, most gentle human beings I know,” added Harris. “. . . This was an attempted modern-day lynching.”

Except, it wasn’t.

Sadly, such race crime hoaxes continue to pop up. In a 2020 column, Dennis Prager noted that “a ‘noose’ was found in the Talladega, Alabama, racetrack garage

assigned to black NASCAR driver Bubba Wallace.”

However, Prager continued, “FBI investigators determined it to be one of several such ropes placed sometime the year before in Talladega garages as door pulls, long before that garage was ever assigned to Wallace.”

But race hustlers like Sen. Rosen still keep trying to play the race card—especially against law enforcement officers.

In May 2020, Rosen signed a letter to the attorney general calling on him “to immediately open an investigation to evaluate unconstitutional patterns and practices of violent policing targeting communities of color.”

The following month, Rosen co-sponsored the “Justice in Policing Act,” writing that “we must take action to address systemic racism and unjust behavior in our criminal justice system.”

But critics noted that her bill would increase costs, increase bureaucracy, hurt police morale, hurt police recruitment, endanger police officers, strain the relationship between cops and the communities they protect, infringe on officers’ constitutional rights, and be exploited for political gain.

Speaking of which . . .

During his 2020 campaign for president, Joe Biden said in an interview with a black host, “If you have a problem figuring out whether you’re for me or Trump, then you ain’t black.”

Indeed, for decades now Democrats have been able to take the black vote for granted. But the times, they are a-changin’.

Going into the 2024 election cycle, polls were showing Trump making substantial inroads with black voters, with some predicting his share of the vote could be 14% or higher, especially in a number of swing states.

Why?

One prominent reason often voiced is the breakdown of law and order in many American cities where sightings of an elected Republican are almost as rare as sightings of Big Foot.

Another is education, where black and other minority students—especially Latinos—are often trapped in failing public schools in low-income neighborhoods.

“One step toward healing the racial divide in our nation and working to dismantle systemic racism is through education,” Sen. Rosen wrote in July 2020.

Yet in April 2024, the *Daily Mail* reported that the Seattle school board had “shuttered

its gifted and talented [schools] because the school board determined they had too many white and Asian students.”

Worse, the school board vice president referred to black students in the gifted program as “tokens.”

Black parents whose children were in the gifted program were not amused and objected to the program closures. One black father pleaded at the board meeting,

My request is that you please consider the disservice you would be doing to the minorities that are already in the [gifted] program. The program does more for black children, particularly black boys, than it does for their peers.

Which is why so many minority parents are joining one of the fastest-growing movements in the country today: school choice.



## Chapter 8

### The Fight for Educational Freedom Heats Up

Henry Ford, founder of the Ford Motor Company, once famously declared, “Any customer can have a car painted any color that he wants so long as it is black.”

It’s a slogan that’s apparently been adopted by defenders of government-owned/union-managed schools: any kid can go to any school he or she wants . . . so long as it’s a public school.

But even that’s not true in many cases.

Charter schools are public schools that have greater flexibility in hiring and curriculum than the regular public schools. But anti-school-choice advocates regularly try to restrict, if not eliminate, them entirely.

Nevertheless, the real fight is over giving low- and middle-income families the financial assistance they need to send their children to a private or church or trade school since the public school system is failing so spectacularly.

In June 2023, *Public School Review* published a report on the biggest failures of the American public education system. They include

- Decline in school safety
- Failure to keep up with technology
- Problems with controversial curriculum
- Over-emphasis on standardized testing
- Teacher “tenure” that protects bad teachers
- Bullying in schools
- Overcrowded classrooms
- Insufficient parental involvement
- Outdated teaching methods

In September 2023, it was reported that 13 high schools in Baltimore City, Maryland, had zero students pass their state math exam. *Zero*. Not one student.

Nevada, overall, isn’t much better. Our state—led primarily by failing public schools in Clark County—regularly lands near the bottom of every list when it comes to education.

School choice was already gaining steam across the country before COVID hit. But

after the government closed public schools during the pandemic, more and more parents began opting for alternatives, including homeschooling, micro-schooling, and pod-schooling.

The genie is now out of the bottle. The movement to give parents not only the right to choose their children's school but the financial means to exercise that right is growing by leaps and bounds.

Valeria Gurr is a first-generation immigrant from Argentina who fights for school choice in Nevada for the American Federation for Children. In a column published by *The Hill* in May 2024, she wrote,

When I first came to this country, I became a Democrat and even worked for the teachers' unions. It quickly became clear to me that the education establishment does not represent my community's best interests. It's also clear that President Biden and the Democratic Party have continued to choose the teachers unions over my family. . . .

When I worked for the union in Nevada, I realized that they were in the business of hoarding power, not

improving working conditions for teachers or education options for children. I left the unions and the Democratic Party. Many Hispanic families are doing the same today.

Democrats ignore education voters at their own peril. Hispanic support for school choice is high and rising, up 8 percentage points since 2020 to 71 percent, in a recent poll commissioned by my organization.

Bottom line: Sen. Rosen doesn't support a parent's right to pick which school their child goes to. She's in the pocket of the modern-day teachers' unions *that donate lots of money to her* and that want to trap kids in failing public schools based on their zip code.

If you want school choice for all kids, don't choose Biden/Harris Democrats such as Sen. Rosen.

## Chapter 9

### **Rosen on Abortion: Fighting Back or Fear-Mongering?**

Do you remember the old “Calvin & Hobbs” comic strip?

Calvin was a 6-year-old boy and Hobbs was his stuffed toy tiger who only came to life in Calvin’s imagination. They had many a great adventure together. In one instance, Calvin advised Hobbs,

Calvin: “I’m writing a fundraising letter. The secret to getting donations is to depict everyone who disagrees with you as the enemy. Then you explain how they’re systematically working to destroy everything you hold dear. It’s a war of values! Rational discussion is hopeless! Compromise is unthinkable! Our only hope is well-funded antagonism, so we need your money to keep up the fight!”

Hobbs: “How cynically unconstructive.”

Calvin: “Enmity sells.”

When it comes to the hot-button issue of abortion, I’m starting to think Calvin is writing for Sen. Rosen.

In 1990, the citizens of Nevada enshrined certain abortion rights in state law through a ballot initiative. And those rights can only be changed through another vote of the people. Not Washington, D.C. Not the governor. Not the legislature. *Only the People of Nevada.*

As explained by the Nevada Division of Public and Behavioral Health (DPBH) on its website,

Abortion is safe and legal in the State of Nevada. Any person in Nevada who is pregnant has the legal right to choose to have an abortion when performed by a licensed physician within the first 24 weeks of pregnancy. An abortion may be performed after 24 weeks where the physician has reasonable cause to believe an abortion is necessary to preserve the life or health of the pregnant person.

Like it or not, that law has been on the books for over 30 years, and there is absolutely no effort underway to repeal it. But that hasn’t stopped Sen. Rosen from campaigning and fundraising off it.

In July 2023—a year after the Supreme Court reversed the *Roe v. Wade* decision and returned the abortion issue to the states—Rosen wrote a Calvin-like op-ed for the *Las*

*Vegas Sun*, describing the decision as “devastating to women.”

She acknowledged that

Nevada women continue to have the freedom to make their own health care choices. But we must be realistic about the threats that lie ahead for all women, including those in Nevada. . . . This all-out assault on our reproductive freedoms is beyond wrong, and I want you to know that I’m fighting back in the U.S. Senate. Republicans in Congress have shown a desire to push forward with their plans for a national abortion ban. But let me be clear: We won’t let them.

Of course, *no such national abortion ban has been proposed in the Senate*. And even if such a proposal were submitted, there’s no chance of it getting the 60 votes needed to overcome a filibuster.

Cynically unconstructive, indeed. But enmity sells. And Sen. Rosen hopes to sell this “political junk food” to the voters of Nevada in November. Sadly, many will buy it.

## Conclusion

Without a doubt, America is on the wrong track and heading in the wrong direction.

If Kamala Harris is elected, things are only going to get worse. If Harris and her chosen vice president are replaced by other Democrat candidates, after this book was printed in early August, nothing will change. *Because the national Democratic Party has changed*. If Democrats continue to control the U.S. Senate, the trainwreck will occur even sooner. If Jacky Rosen is re-elected to the Senate, Democrats are more likely to keep their power.
